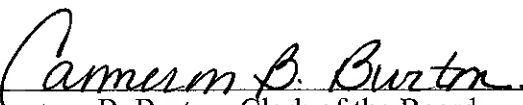
APPLICATION TO THE WYTHE BLAND FOUNDATION
