-The State Board of Elections certified the results of the November 7, 2023 General Election on December 4, 2023.

The deadline for candidates to file for the March 5<sup>th</sup> ballot was on December 14, 2023. The parties have until 5:00pm December 19, 2023 to certify the candidates. The State Board will meet on December 20, 2023 at 1:00pm to determine ballot order. Ballot proofing/approval will begin immediately after. Early voting will begin January 19, 2024.
