Chairman Mercer requested some goals or a timeline for the Comprehensive Plan review. County Administrator Burton that she would speak with MRPDC and attempt to have the updated data and a MRPDC representative at the October Planning Commission meeting and the review could begin after that.

Commissioner Dodson stated he had two requests, that MRPDC would provide "trends and suggestions".
